The birth of the universe assumes that the existence of zero causes the release of infinite energy and the creation of space in the collapse of its balance. These are infinite energies, but I think that the amount of energy is limited at the constant of a . This equally gives the assumption that all physical beings are the solidification of energy. The commonality in eternal motility in a resident physical phenomenon assumes a fluctuation constant f in the collapse of zero balance, and this persistence forms time.

The expansion of space and the formation of physical beings are the expansion of infinite energy, which we define equally as the Big Bang.
